General Safety Discipline regarding Fuel

Transport must conform to the prevailing European laws and the paddock prescriptions of the safety agreement of the circuit. Within the paddock and pit enclosure, fuel may only be transported in jerry cans or metal drums with a capacity of maximum 60 litres and with a maximum of 240 litres being transported at any one time. The people responsible for transporting the fuel must be equipped with a powder or foam-type extinguisher, weighing a minimum of 6 kg, during the entire operation; this extinguisher must be in working order and have been stamped by the Scrutineers or by technicians from the extinguisher company present at the event.

The transported jerry cans must be separated firmly attached to the transporting vehicle (mini pick-up (e.g. John Deere, golf buggy, etc. or towed trailer). The towing vehicle (generally a quad bike) must be adapted to be able to tow the load and be provided with a coupling system backed up by a safety device (chain, strap, etc.).
