Art 5 – Scrutineering & Parc Fermé

- a. Technical Scrutineering & the Driver's Equipment check will take place in the W Series awnings in the Support Paddock on Thursday 26th August from 10h00 to 16h00.
- b. The drivers are to remain in Parc Fermé for 15 minutes after each session.
- c. Post-race scrutineering will take place in the W Series Support Paddock.
- d. Leaving the track after the race: All cars will take the chequered flag and then leave the track and go immediately back to the W Series Awnings under Parc Fermé conditions. Except for the first three finishers who will continue to the winner's podium and then onto post-race scrutineering.

Art 6 – Entry

This event is open for registered drivers holding an international grade C licence (or higher).

Art 7 – Administrative Checks

The administrative checks will take place online on Thursday 26th August. Time TBC.

The driver must be present at the place and the time indicated for the administrative checks and for the scrutineering. At the administrative checks the driver must show their licence.

Drivers from outside Belgium or comparable countries by decision of the FIA need written consent from their own ASN (FIA ISC Art. 2.3.7).

Art 8 – Extrication Test

A mandatory extrication test will take place on Thursday 26th August at 14:00, Location: W Series Awnings. The driver to complete the extrication test will be nominated by the W Series Technical Delegate.

Art 12 – Regulations Amendments & Clarifications

W Series Bulletin No.1 has been issued outlining some changes to the Judicial Procedures in Art.24 of the Sporting Regulations and the correction of a typing error in Art 44 of the Technical Regulations.

Art 13 – Classified finishers

Cars having covered less than 90% of the number of laps covered by the winner (rounded down to the nearest whole number of laps), will not be classified.

Art 14 – Permitted changes to the Set-Up parameters

The Technical Delegate has issued a document confirming the permitted changes to the Set-Up parameters for this round. This diagram can be seen at the end of this document.

Art 15 – Standards of Conduct

In order to maintain standards of conduct, at any time during the event the Championship reserves the right to impose a penalty on any driver (or member of her mechanics/team/sponsor), without reference to the Stewards of the Meeting. This does not apply to any type of flag/contact incident. It could also result in a Championship steward's enquiry with possible loss of Championship points.
