**16 Flags and Light Panels**

Where flag signals are supplemented by light panels/signals, both means of signalling will be deemed to have regulatory value. For reasons of safety, in case of conflicting signals between the flags displayed by marshals and the light panels, drivers must comply with the requirements of the signal with the highest level of safety. In order of precedence: Red Flag, Safety Car, Double Yellow Flag, Single Yellow Flag, Green Flag.

**17 Basis of Classification**

The classification will be established in accordance with the Porsche Mobil 1 Supercup Sporting Regulations based on the results of the official timekeeping of the event.

**18 Trophies and Prize money**

Trophies for the first three drivers plus other awards as defined in the Porsche Mobil 1 Supercup Regulations 2022.

**19 Protests**

Protests arising out of the competition shall be delivered to the Race Director.
