



## WAIVER OF RECOURSE - Passengers

The undersigned,

Declares to be fully aware of the risks associated with motor sports, which by their very nature can never be completely safe.

Declares to be aware that taking a seat as a passenger in a two-seater race car exposes them to the risk of an accident caused either by a loss of control of the vehicle by the driver, who is trying to achieve the best possible performance and thus pushes the vehicle to its limits, or by a malfunction of the vehicle subject to extreme stress, or due to contact with another competitor in the same conditions.

Declares to understand that the consequences of an accident may be significant for their physical integrity, given the speeds involved, which are higher than those permitted on public roads.

Declares to seek out such speed for the sensations it provides and to have invited the driver to achieve such speeds.

Declares, under these conditions, their desire to participate in the event on \_\_\_\_\_ (date of the event) including free practice, qualifying sessions, and races, under their full responsibility and at their own risk, thereby irrevocably waiving, for themselves and all their rightful claimants, any recourse, of any kind, against Kronos Events, RACB Sport, the owners or operators of the site, staff, drivers, and other participants, the owners of the racing vehicles, officials and volunteers, as well as the insurers of the aforementioned individuals, companies, or organizers.

Commits to comply at all times with the general, technical, and specific regulations of the Fun Cup, as well as the instructions of marshals, officials, organizers, or site operators.

Declares to understand that during the entire duration inside the vehicle, they must refrain from any movement that could hinder the driver.

I hereby declare to waive any and all claims on behalf of myself, my successors, my heirs, my relatives (parents, spouse, children), and our insurers, against:

- The National Sporting Authority represented by RACB Sport
- The owner(s) and/or operator(s) of the circuit
- The organizer(s) of the event
- Other participants
- The competitors and owners of competing vehicles
- The staff, volunteers, and officials mentioned above
- The insurers of the persons or entities listed above

For any damage I may cause or suffer during any of the events (including practice sessions) held under the sporting jurisdiction of RACB Sport.

In the event of death, this waiver of recourse shall also constitute a binding agreement on behalf of my successors, heirs, relatives, and our insurers.

### **Summary of the Coverage of the Personal Accident Insurance Policy "Pass Passengers"**

**Policy No.:** 730.267.658

#### **Scope of Coverage:**

The purpose of this policy is to guarantee the payment of the benefits listed below in the event of bodily injury accidents occurring to the insured during the aforementioned sporting event under the patronage of RACB Sport. The insured persons are drivers and/or passengers holding a "One Day" license or "Passenger Pass" issued by RACB Sport. This coverage is valid in European countries affiliated with the FIA.

#### **Coverage per insured and per accident:**

- **Death:** €25,000
- **Permanent Disability:** €25,000
  - English deductible 10% (no compensation for disabilities less than or equal to 10% – full compensation applies when disability exceeds the deductible percentage)
- **Medical Expenses:** €2,500
  - Deductible: €125 per claim
